AMENDMENT

This Amendment made and entered into this 24th day of October 2025, in the state of California by and between the Trustees of the California State University, which is the State of California acting in a higher education capacity, through its duly appointed and acting officer, hereinafter called ("University") and

U.S. BANK NATIONAL ASSOCIATION, hereinafter call the ("Contractor"),
(this "Amendment")

WITNESSETH: That the Contractor for and in consideration of the covenants, conditions, agreements, and stipulation of the University hereinafter expressed, does hereby agree to furnish to the University services and materials as follows:

Original Agreement 40079178, dated October 31, 2011, including its First Amendment to Exhibit E dated August 2, 2016, and First Amendment to Exhibit A dated October 30, 2019, and the Second Amendment to the Agreement Dated July 20, 2020, for the Campus ID Card Banking Services and is hereby amended as follows:

- 1. Amendment of Term.** This Agreement will remain in effect until October 31, 2027, to be coterminous with the West Commons Branch Licensing Agreement term between U.S. Bank and Aztec Shops.

To support this change in Term, the following Exhibit H Section 7 has been revised:

TERM: October 31, 2011, through October 31, 2025

CHANGE TO: October 31, 2011, through October 31, 2027

- 2. Amendment of Operations Schedule.** Section 6.1 Operations Schedule and Section 6.1 Card Operations Payment will be deleted in their entirety and the following language will be substituted for all purposes.

6.1 Operations Schedule.

6.1.1 Card Operations Payment. Bank will pay to University \$130,000 per year (a "Card Operations Payment"). The annual Card Operations Payment will be made prior to October 31st of each year during the Term of the Agreement, with the first payment being made prior to October 31, 2026 and then annually for the remaining Term of the Agreement.

All other terms and conditions of the Original Agreement shall remain in the same and in force.
